The Unlawful Internet Gambling Enforcement Act (UIGEA) was passed in 2006, giving the States the right to regulate gaming over the Internet. In 2012 Illinois launched the first iLottery in the US, and 2013 New Jersey allowed iGaming in the US. Today there are eleven states with iLottery and six states with iGaming. In 2018 the Supreme Court of the United States repealed the Professional and Amateur Act. Within two months, New Jersey had an operation live on their mobile, and now 37 states have adopted sports betting. Why did iGaming and iLottery fall behind? Why did Sportsbetting move so quickly? What can we learn about Sportsbetting growth that could help iLottery and iGaming?
